Founded on August 29th, 1997 in Scotts Valley, California, Netflix is said to be the 10th largest internet company by revenue.

Originally only offering video-on-demand online and DVD by mail, they entered into the content-production industry in 2013 with it's debut of "House of Cards". Now Netflix is said to have released an estimated 126 original series or films in 2016.

As of October 2017, Netflix had an estimated 109.25 million subscribers worldwide.



Hulu is a subscription video on demand service. Owned jointly by The Walt Disney Company, 21st Century Fox, Comcast and Time Warner, it primarily offers streaming of television series (current and past episodes) from its owners' respective television networks and other content partners.



Over time they switched to marketing their software as a Smart TV/Connected TV platform and Video on Demand to third-party consumer electronics devices. Restrict Unwanted Telephone Solicitations

In 2003, the Do-Not-Call Act was signed into law. This legislation allowed for the establishment and enforcement of a national Do-Not-Call Registry giving consumers a choice regarding telemarketing calls. If your number is listed on the registry, all commercial telemarketers, except for businesses with whom you have an existing relationship or certain non-profit and political organizations, are not allowed to call you.

Consumers may register their residential telephone number, including wireless numbers, on the national Do-Not-Call Registry by telephone or by Internet at no cost. **To register by telephone, consumers may call 1-888-382-1222. For TTY, call 1-866-290-4236.** You must call from the phone number you wish to register. **You can register on-line for the national Do-Not-Call Registry via the internet at www.donotcall.gov**

Inclusion of your telephone number on the national Do-Not-Call Registry will be effective 31 days after registration. Your number will remain on the registry permanently. You are allowed to remove your number from the registry at any time.

FUSC Update-Federal Universal Service Charge

Effective January 2, 2018 the Federal Universal Service Charge (FUSC) contribution factor will be increasing from 18.8% to 19.5%. The FUSC amount is calculated by multiplying the contribution factor times your interstate service charges. This factor may change quarterly, depending upon the needs of the Federal Universal Service Fund (USF). The USF is a government mandated program that is designed to help make phone service affordable and available to all Americans, including consumers with low income, those living in areas where the costs of providing telephone service is high, and to schools, libraries, and rural health care providers.

Uber Data Breach

Uber has suffered a data breach a year ago, and the address and email information of 57 million people were stolen. Uber paid off the hackers who then supposedly deleted the data, but that cannot be confirmed.

Watch out for phishing emails related to this Uber data theft, for instance that your "Uber account was compromised" and that you need to change your password, or anything else related to Uber that could be suspicious.

Never click on a link in an email, always go to the website yourself through your browser's address bar or a bookmark you have set earlier. **Remember, Think Before You Click!**
